The manuscript should be prepared in the following format :

Every paper must be accompanied by a cover page, which should include the title of the paper, name(s) of the author(s) and their affiliations, resident country and the complete postal and e-mail addresses and telephone numbers of the authors.

Abstract font size should be 12, Times New Roman, & 1.5 line spacing.

Title of the Paper should be 16 font size.

Abstract of not more than 500 words with keywords

The Research Papers should be in a word document format, Times New Roman, font size 12 with 1.5 line spacing, 1 inch margins and APA style of referencing.

The Word Limit for the Research is limited to 4500 words, and must include the following: Title, Objectives of the study, Methodology, Findings, Conclusion/Implications/Recommendations. Limitations, References.

All tables & diagrams should be properly numbered.

The institute has a strict anti-plagiarism policy, therefore, the authors must ensure originality of the work

Selected papers will be informed through mail. The decision of the review committee regarding the selection of papers will be final and binding.
